# Additional funded places for university Paramedic Education and Pre-registration Nursing and Midwifery students recruited in AY 2020-21

#### **Purpose**

1. I am writing to announce additional funded Paramedic Education and Pre-registration Nursing and Midwifery places to be allocated to universities in Academic Year (AY) 2020-21 following the Scottish Government's statement regarding 2020 SQA results.

### **Background**

- 2. On 26 August 2020, SFC published an announcement regarding <u>additional</u> <u>university places in 2020-21 following 2020 SQA results</u>. This announcement provided guidance on additional funded student places that would be allocated to universities in AY 2020-21 following the Scottish Government's statement regarding 2020 SQA results.
- 3. Additional funding has been provided as a result of 2020 exam results being regraded and followed the Deputy First Minister's commitment that the Scottish Government would "make provision for enough places in universities and colleges to ensure that no one is crowded out of a place they would otherwise have been awarded." SFC wrote to universities on 9 February 2021 confirming the additional places and funding for AY 2020-21.

### **Funding and additional places**

#### **Paramedic Education**

4. Funding of circa £0.3 million has been provided for 58.0 additional Paramedic Education funded student places that have been allocated to universities in AY 2020-21 for Scottish-domiciled/European Union (EU) students. These additional places have been allocated to three universities in line with the over-recruitment above their intake targets in AY 2020-21. A breakdown of this additional allocation of funded places by university is shown in Table 1 (below).

#### **Pre-registration Nursing and Midwifery**

5. Funding of circa £3.4 million has been provided for 476.3 additional Nursing and Midwifery funded student places that have been allocated to universities in AY 2020-21 for Scottish-domiciled/EU students. This additional provision has been allocated to seven universities to provide places for an additional 398.3 students on the three-year degree programme, and to five universities to provide places for an additional 78.0 students on the four-year honours degree programme. The allocation of these additional places is in line with the over-recruitment above their intake targets in AY 2020-21. A breakdown of this

- additional allocation of funded places by university is shown in Table 2 (below).
- 6. These additional students, for both Paramedic Education and Pre-registration Nursing and Midwifery, will be funded for the full length of their degree programmes. In modelling the funded places for future years, the places associated with this additional funding will be identified separately.
