# In-year redistribution of student support funds for AY 2018-19

### Purpose

 This letter announces the in-year redistribution of student support funding to colleges for academic year (AY) 2018-19. It details the recovery of unspent funds from AY 2017-18 and the allocation of additional funding for AY 2018-19.

# Background

- 2. Demand for student support is unpredictable and, in order to match our funding to demand as closely as possible, we carry out an in-year redistribution. We do not allow colleges to use student support funding for other purposes; we recover funds that colleges do not expect to use in the current year, as well as any unspent funds from the previous year. We use the funds returned to us to allocate to colleges that need additional student support in the current year.
- 3. We invited colleges to relinquish unspent student support funds or request an increase to their AY 2018-19 student support allocations in a Call for Information published on 19 October 2018 (<u>SFC/CI/04/2018</u> *In-year management of student support allocations for 2018-19*).

# Redistribution

4. The total amount of student support funding requested by colleges is £11.7 million (as set out in Annex A column 1). There is £11.7 million available for redistribution (Annex A column 2). Therefore SFC will be able to meet, in full, colleges' requests for additional student support funding for 2018-19. The table in Annex A details the amounts requested and relinquished by each college / college region. The table shows the total additional funding to be paid out in AY 2018-19 along with a breakdown across the two financial years (FYs).

# Funds available for redistribution

- 5. The total amount of student support funding SFC has available for redistribution is £11.7 million. This comprises the following elements:
  - **£4.8 million for care experienced bursaries.** £5.2 million was initially allocated to SFC from the Scottish Government as part of our 2018-19 funding settlement for the purpose of implementing changes arising from the Scottish Government's response to the Independent Review of Student Support. However, at the time that SFC was publishing its core funding announcement, the details of the changes to be made to student support funding had not yet been decided. Therefore this amount was not included in colleges' core allocations of student support, but was set aside to be distributed later in the

year, as detailed in our final <u>outcome agreement funding allocations</u> for 2018-19. The Minister announced in June 2018 that the additional funding would be used to introduce a new, higher rate bursary for Care Experienced students, as announced in <u>our letter</u> to the sector. Of the £5.2 million, £0.4 million was transferred to the Student Awards Agency Scotland (SAAS) for Care Experienced bursaries for HE students, with SFC retaining the remaining £4.8 million.

- £4.2 million of unspent funds from 2017-18. Colleges are returning £4.2 million that they did not spend in AY 2017-18, for redistribution. This amount is calculated on the basis of the 2017-18 initial allocation, plus the in-year redistribution together with the European Social Fund (ESF) final student support allocation, and compared to the final 2017-18 student support spend recorded in the Further Education Statistics (FES) return. The amount of unspent funds being returned to SFC is in line with the amounts returned in recent years and represents 4% of the overall funding available for student support in 2017-18.
- £2 million of funds not required in 2017-18. The 2017-18 outcome agreement funding announcement included £2 million for use in the student support in-year redistribution. The colleges returned more than they requested, hence this £2 million was not required in 2017-18.
- £0.7 million of unspent funds from 2016-17. In the 2017-18 redistribution exercise, colleges returned £7.1 million of unspent funds for 2016-17, but only requested £4.3 million in additional funds. As set out in last year's <u>announcement</u> on the redistribution, SFC set aside the remaining £2.8 million with the intention of using it to cover any future gap in European Social Fund (ESF) student support funding. Although the audit of the ESF projects is not fully complete, we have decided to use £0.7 million of this funding for this year's redistribution exercise.

#### Funds requested by colleges

- 6. The total amount of student support funding requested by colleges is £11.7 million. This comprises the following elements:
  - Circa £7.6 million additional required for Care Experienced bursary. Although we do not have an exact baseline of previous Care Experienced bursary costs, the request for additional funds has increased considerably and we estimate it includes £7.6 million of additional funds required to meet the costs of the Care Experienced (CE) bursary which was introduced in 2018-19. The increased bursary for CE students was not announced until June 2018, after the core funding allocations for student support in 2018-19 had been published. It was also not clear at that stage what the take-up of the CE bursary would be.

Therefore SFC asked colleges to wait until the in-year redistribution exercise to request additional funding, so that we could match our allocation of the funding as closely as possible to the student demand.

• **£4.1 million for core student support.** As with the past three redistribution exercises, the amount requested for core activity is lower than the amount requested prior to 2015-16. This is as a result of work SFC has undertaken with colleges to improve the in-year redistribution process and the accuracy of funding bids submitted. It also reflects changes in the student demographic and changes in colleges' balance of full-time, further education provision. The slightly later timing of the redistribution exercise has also helped colleges produce more accurate bids, as their student populations are more settled.

#### Recovery of unspent funds and adjustments to budgets

- 7. Colleges receiving additional funds will have their Financial Year (FY) and Academic Year (AY) student support budgets increased by the amount of additional funding that they have been awarded, as detailed in the Table at Annex A. These updated budgets will be reflected in incorporated colleges' monthly cash-flow pro-forma. Colleges should continue to drawdown funding based on need whilst giving due regard to the revised FY budget.
- 8. For multi-college regions, we have set out in the table in Annex A the amounts requested by individual colleges within each region. Regional boards should note the allocations to individual colleges. Multi-college regions may action in-year transfers of student support funding between colleges within the region.
- 9. Colleges that are returning unused funds will have their overall FY student support budget reduced by the amount of funding that they are returning. For those colleges that have already made adjustments to their budgets in June 2018, the March 2019 adjustment to be made will take into account the funds previously returned. This is shown in Annex B, under the Column 'Remaining funding adjustments to be made in March 2019'.
- 10. Sabhal Mòr Ostaig, Newbattle Abbey College, SRUC, Orkney College, Shetland College and West Highland College do not submit cash-flow pro-formas. For these colleges, relinquished funds will be clawed back in March 2019. Where these colleges are to receive additional funds, payments will be adjusted in March and April 2019 as set out in Annex A.
- 11. Colleges will not be able to claim funding above the revised budgets. #### Management of payment of funds

12. Colleges are reminded of the change to the management of the payment of funds which SFC implemented for the first time last year; that is, we will contact colleges in early June 2019 to seek clarification of their near final position on spend on student support in 2018-19. Colleges that have drawn down their full student support budget but are forecasting a significant underspend against their budget will be asked to reduce their July 2019 draw-down of funds or return surplus funds to SFC in July 2019, rather than waiting until the 2019-20 redistribution exercise in Autumn 2019.
