## **TERMS OF REFERENCE**

### ROLE

- 1. The Regional Tertiary Provision Pathfinders National Advisory Board (NAB) has been established to provide strategic guidance and direction, support, and challenge to the Regional Tertiary Provision Pathfinders ("Pathfinders") projects.
- 2. The NAB will make a particular contribution to learning and recommendations arising from the activity associated with the Pathfinders. The important advisory function provided by the Board will shape the Pathfinders work and will inform reporting to related governance fora including SFC's Board, the Shared Outcomes Assurance Group, the Pathfinders Learner Forum, and ministerial updates.

#### **MEMBERSHIP**

- 3. The National Advisory Board is comprised of stakeholders from across the tertiary education system, academic, civic society, and beyond. The Board will be chaired by Karen Watt (Chief Executive Scottish Funding Council).

### **GOVERNANCE AND WAYS OF WORKING**

- 7. The NAB will be serviced by the Pathfinders Team within the Scottish Funding Council.
- 8. The National Advisory Board will meet predominantly online on an agreed timescale (likely every 2-3 months), through to the end of 2023. While its primary remit is to support the delivery of the Pathfinders, individual perspectives and insights may be sought to inform related activities arising from the programme.
- The outputs of the Pathfinders projects will have particular relevance to decisions made by SFC's Board and Committees; its executive; Scottish Ministers; and SFC-funded bodies.
- 10. The NAB has an advisory role in the oversight and development of the Pathfinders projects. The Pathfinders are one of a number of joint agency projects between SDS and SFC, and as such SFC reports to the Scottish Government's Shared Outcomes Assurance Group on their progress.

#### PRINCIPLES AND SCOPE

- 11. The Regional Tertiary Provision Pathfinders National Advisory Board (NAB) membership brings together a wealth of experience and expertise from across education, academia, civic society and beyond, from a range of contexts.
- 12. Scottish Government's response to the SFC Review and its annual letter of guidance positioned the Regional Pathfinders as a ministerial priority. The Pathfinders are of significant regional and national policy importance, being an action of the National Strategy for Economic Transformation and connected to regional policy commitments in the North-east and South of Scotland. Board matters will thus be wide-ranging, drawing on related policy drivers and influences surrounding the Pathfinders' implementation.
- 13. National Advisory Board members have been invited to advise throughout the course of

the Pathfinders programme. Members will make a particular contribution to shaping the learning and recommendations arising from the activity undertaken. They will also be encouraged to share their perspectives and expertise more widely, to inform SFC's wider work on coherent provision.
