

# Student Mental Health and Wellbeing Transition Fund in Academic Year (AY) 2023-24

#### Summary

1. I am writing to announce the funding allocations under the one-year Student Mental Health and Wellbeing Transition Fund for colleges and universities in Academic Year (AY) 2023-24. The aim of this funding is to provide financial support for a transition from the previous arrangements<sup>1</sup> to one which helps institutions diversify their support offering to students and explore delivery models which meet student needs and integrate with local services. This funding has been allocated by the Scottish Government.

#### Purpose of funding

- 2. In its 2018 <u>Programme for Government</u>, the Scottish Government committed to 'provide more than 80 additional counsellors in Further and Higher Education over the next four years with an investment of around £20 million'. The Scottish Funding Council (SFC) announced the first year of this funding in November 2019<sup>2</sup>. We are grateful that the tertiary sector has been able to deliver this commitment and continue to support student mental health. This commitment has now been fulfilled and the funding associated with it concluded at the end of AY 2022-23.
- 3. As student mental health is an important area for the Scottish Government, a one-year Student Mental Health and Wellbeing Transition Fund has been created to support institutions' transition from the previous funding, which focused on supporting additional counsellor provision, to a sustainable approach to support student mental health. We recognise some institutions may want to use the fund to continue supporting their counselling provision while others may want to explore funding new or existing initiatives and, therefore, suggested actions this funding supports could include but are not limited to:
  - Counselling provision.
  - Online mental health services or resources.
  - Engaging with local support services.
  - Early intervention/Internal support mechanisms.
  - Mental health advisers/nurses/coordinators.

- Peer to peer student support.
- Student wellbeing officers.
- Pilot and evaluate approaches to support mental health and wellbeing.
- 4. Funding should not be used to fund specific managerial roles and should be used primarily to support mental health and wellbeing services for students.
- 5. As institutions plan for future support, SFC expects them to engage closely with students and student associations. We also strongly encourage institutions to work together, where possible, to ensure high quality and relevant support is available to students throughout their learning journey.

#### Funding for AY 2023-24

6. The Minister for Higher and Further Education wrote to Colleges Scotland, Universities Scotland, and NUS Scotland on 11 July 2023 to announce that the Scottish Government will provide £3.21 million for AY 2023-24 as a one-off funding allocation in respect of mental health and wellbeing support in colleges and universities. The college and university sector and each institution will receive a proportionate share of this one-off funding, informed by their share of the funding for the final year of the previous commitment on counsellors in AY 2022-23.

#### Conditions of grant

- 7. This funding must only be used for the purpose(s) for which it is being allocated, as outlined above. SFC retains the right to audit relevant institutional documentation to satisfy itself that this is the case (and the institution undertakes that it will provide such assistance as SFC reasonably requires).
- 8. Funds should be spent by the end of AY 2023-24. However, institutions may carry forward any unspent funds from this allocation and the previous allocation of <u>Funding for Counsellors AY 2022-23</u> to support student mental health and wellbeing, including any transitions needed to embed a more sustainable approach.

#### Payment of funds

9. Allocations for AY 2023-24 are set out in the tables in Annexes A and B. Payments to universities and non-incorporated colleges will be made in two Financial Year instalments in November 2023 and April 2024 for the August 2023 to March 2024 and April to July 2024 allocations respectively. Incorporated colleges/regions should draw down funds as required, as per their monthly cash flows, and may draw down their August to March allocations over the period to March 2024, and April to July allocations over the period April to July 2024. Payments are subject to acceptance of this offer of funding.
